RE: Lassen County Proposed Septic Policy to which is proposed to be presented to the Lassen County Board of Supervisors on January 21, 2019.

This policy, known as the Lassen County Local Agency Management Program (LAMP), is about to be implemented. The policy was developed in cooperation with Lassen County Environmental Health Department, and the California Regional Water Quality Control Board, Lahontan Region.

This policy, once adopted by both the Lassen County Board of Supervisors and the Regional Water Board, and put into the Lassen County Ordinance, will regulate how Onsite Wastewater Treatment Systems, aka Septic Systems, are designed, approved and installed.
