2. PUBLIC COMMENT/UNAGENDIZED DEPARTMENT REPORTS

Jennifer Branning mentioned that the sign up for the Torch Run for law enforcement officers is open. Event starts 7 am on June 16th, at the Historic Courthouse.

3. INFORMATION ITEMS

A. Jail Update – *John mentioned the population is 109, 41 sentenced, 30 male sentenced, 9 female sentenced, 68 non-sentenced, 61 male non-sentenced, 9 female non-sentenced, 8 1170h, 13 Shasta. Looking at buying another transport van. Sewage grinder is being worked on. 7 officers have graduated from CORE, 1 to go into training, 6 to go to the floor. New educational programs that are app based. Evaluating the control system and cameras, to see what may need upgrades. Outside crew now out working, Langslet in charge at the Ronald McDonald camp. The number of staff assaults is rising; 5 total, 4 needing medical attention. There will be a staffing analysis to ensure proper safety and how to maximize staff. Nights are at minimum staffing, while days are currently below. There are an additional 6-10 FTE's going to budget.*

B. Mental Health Placement/Beds Updates - *no new updates at this time.*

C. Cal-Aim/Care Court- *Still new, will take more time and meetings to fully set up.*

- D. Data Update – *Linsay Adams mentioned caseload numbers in Adult Supervision are 22 PRCS, 5 Mandatory Supervision, 64 Felony Supervision, 4 Pretrial. Of those, there are 22 Low Risk, 30 Moderate Risk, and 43 High Risk.*
- E. Probation/DRC Updates – *Jennifer Branning mentioned the Pretrial program – 4 on Supervision, Probation to send the list to dispatch. The money for Pretrial is now to carryover to be spent by next fiscal year. The department is currently short staffed, likely to onboard staff soon, applications are in and interviews are being conducted.*
