

SB 272

Approved on October 11, 2015, and subsequently chaptered as California Government Code Section 6270.5, this bill adds a section to the California Public Records Act requiring local agencies to create a catalog of its enterprise systems by July 1, 2016, and post that catalog on their respective website, if the agency has an internet website.

The information identified below is the Catalog of Information Systems for the County of Lassen. It is inclusive of systems being used by the County of Lassen or other local agencies for which the Board of Supervisors sits as the governing board and/or the County of Lassen provides staffing, administration and services for the agency, and those agencies that do not have a website to post a catalog. Those agencies include: Community Development Commission of Lassen County, Lassen-Modoc Flood Control and Water Conservation District, Bieber Lighting District, and County Service Area #1.

Please be advised that the public identification of these systems does not necessarily mean that the content of these systems will be subject to public disclosure or permit public access to records held by an agency to which access is otherwise restricted by statute or to alter the process for requesting records (GC6270.5(d)).

Enterprise System

A software application or computer system that collects, stores, exchanges and analyzes information that the agency uses that is both of the following:

A multi-departmental system or a system that contains information collected about the public

A system that serves as an original source of data within an agency

An Enterprise System does not include any of the following:

Information technology security systems, including firewalls and other cybersecurity systems.

Physical access control systems, employee identification management systems, video monitoring, and other physical control systems.

Infrastructure and mechanical control systems, including those that control or manage street lights, electrical, natural gas, water, or sewer functions.

Systems related to 911 dispatch and operation or emergency services.

Systems that would be restricted from disclosure by California Government Code Section 6254.19.

The specific records that the information technology system collects, stores, exchanges, or analyzes.

County of Lassen Catalog of Enterprise Systems

Requirements

1. Create a catalog of enterprise systems containing:
 - Current system vendor
 - Current system product
 - System's purpose
 - A description of categories or types of data
 - The department that is the prime custodian of the data
 - The frequency that system data is collected
 - The frequency that system data is updated
2. To make the catalog publicly available upon request.
3. To post the catalog in a prominent location on the agency's website

Exception

The County may instead provide a system name, brief title or identifier of the system, as an alternative to the name of the current system vendor and/or name of the current system product, if the public interest is served by not disclosing that information clearly outweighs the public interest served by disclosure. When an alternative name is being used for the vendor and product name, the catalog will use an identifier of: GC 6720.5(e)-Exception.
