The Bidder acknowledges that the property is purchased "AS IS" and other than the representation contained on the inventory sheet, the seller does not warrant or represent the condition of said property.

The Bidder acknowledges payment will need to be paid in full, prior to the vehicle being picked up, no later than November 30, 2020. Payment will be received at the Lassen County Administrative office at 221 South Roop Street, Suite 4. When payment is received in full, the Buyer will be provided the title for the vehicle. The vehicle must be picked up the same day. If payment is not received by November 30, 2020, the transaction will be terminated and award of the vehicle will be given to the second highest bidder who will have FIVE business days to pay for the vehicle in full or the transaction will be terminated.

The Bidder acknowledges payment in the form of checks may not be deposited for up to five business days. If checks are returned, an alternative form of payment will need to be provided with five business days or actions will be taken to reclaim the vehicle.

The Bidder acknowledges there are minimum bids on certain vehicles and bids lower than the minimum bid will not be accepted.

The Bidder acknowledges they are solely responsible for the removal and transportation of the vehicle from the site.

Vehicles can be viewed on November 16, 2020, at the Lassen County Sheriff's office motor pool site, located at 1405 Sheriff Cady Lane in Susanville.
