

- If you make a mistake in marking your ballot, cross out the incorrect mark and write "Ok" next
 to your correct choice. DO NOT sign or initial your ballot. You may also return the ballot to the election
 office for replacement at 220 S Lassen Street, Suite 5, Susanville, CA.

VOTING BY MAIL:

- Once you have finished voting, remove your ballot stub and place your voted ballot in the envelope provided.

- Your ballot envelope must be postmarked by election day and received by the election's office no later than 7 days after the election.
- Or you can drop-off your ballot at any polling location or Drop-Box in Lassen County before 8PM on Election Day.



IMPARTIAL ANALYSIS OF MEASURE P BY CITY OF SUSANVILLE CITY ATTORNEY OF AN ORDINANCE IMPOSING ONE-CENT SALES TAX

City Attorney's Impartial Analysis:

This ballot measure will establish an additional sales tax within the City of Susanville. The sales tax imposed would be an additional one cent.

This ballot measure will also establish a five-member standing oversight committee composed of Susanville residents. These members will serve as the independent Sales Tax Oversight Board to review the expenditure of funds collected pursuant to the tax imposed by this Ordinance.

A "YES" vote on this measure would allow the City of Susanville to impose an additional one-cent sales and use tax to provide more funding to local law enforcement.

A "NO" vote on this measure is a vote against an additional half-cent sales tax.

IMPARTIAL ANALYSIS BY CITY OF SUSANVILLE CITY ATTORNEY OF THE ADVISORY ONE-CENT SALES TAX

This ballot measure is advisory to the Susanville City Council on the use of the one-cent sales tax, should it be passed. The ballot measure shall recommend the use of the tax revenue to enhance existing public safety services (police and fire); provide funding to support street infrastructure improvements; and provide funding to support economic development efforts designed to increase businesses, jobs, and visitors to Susanville.

A "YES" vote on this measure would advise the Susanville City Council to use the revenue from a one-cent sales tax, to enhance existing public safety services (police and fire); provide funding to support street infrastructure improvements; and provide funding to support economic development efforts designed to increase businesses, jobs, and visitors to Susanville.

A "NO" vote on this measure is a vote to not recommend use of this tax.

Voter Bill of Rights


You have the following rights:

1. The right to vote if you are a registered voter.

You are eligible to vote if you are:

- a U.S. citizen living in California
- at least 18 years old
- registered where you currently live
- not currently serving a state or federal prison term for the conviction of a felony, and
- not currently found mentally incompetent to vote by a court
- 2. The right to vote if you are a registered voter even if your name is not on the list. You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.
- 3. The right to vote if you are still in line when the polls close.
- 4. The right to cast a secret ballot without anyone bothering you or telling you how to vote.
- 5. **The right to get a new ballot if you have made a mistake,** if you have not already cast your ballot. You can:
 - Ask an elections official at a polling place for a new ballot,
 - **Exchange your vote by mail ballot** for a new one at an election office or at your polling place, or **Vote using a provisional ballot**.
- 6. **The right to get help casting your ballot** from anyone you choose, except from your employer or union representative.
- 7. The right to drop off your completed vote by mail ballot at any polling place in California.
- 8. The right to get election materials in a language other than English if enough people in your voting precinct speak that language.
- 9. The right to ask questions to elections officials about election procedures and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.
- 10. The right to report any illegal or fraudulent election activity to an election official or to the Secretary of State's office.
